
Provacore Privacy Policy

Talexes recognizes the importance of protecting the information collected from users in the operation of its services, and takes reasonable steps to maintain the security, integrity and privacy of any information in accordance with this Privacy Policy. By submitting your information to Talexes you consent to the practices described in this policy. If you are less than 18 years of age, then you must first seek the consent of your parent or guardian prior to submitting any personal information.

Talexes will seek to ensure that any identifiable personal information it collects during the registration and purchasing processes will be adequate, relevant and not excessive for purposes of operating its websites or any of its services and it will be kept accurate and up-to-date based on the information provided.

How We Collect Information

Talexes collects information from you in two ways: directly from your input and automatically through Talexes' website technologies.

Information You Provide

The types of personal information that Talexes collects directly from you may include:

- Contact details, such as your name, email address, postal address and telephone number;
- Educational and professional interests and background information;
- Usernames and passwords;

In order to access certain content and to make use of additional functionality and features of Talexes' websites and services, we may ask you to register for an account by completing and submitting a registration form, which may request additional information.

Use of Your Information

Talexes may use your personal information in the following ways:

- To carry out our obligations arising from any contracts entered into between you and us and to provide you with information about products and services that you request from us;
- For internal business and research purposes and to help enhance, evaluate and develop our websites, products and services and to develop new products and services;
- To notify you about changes or updates to our websites;
- To notify you about changes or updates to our products and services if it will have an effect on your use of the system;
- To respond to your requests, inquiries, comments, or concerns;
- To administer our services and for internal operations, including troubleshooting, data analysis, testing, statistical and survey purposes;
- To allow you to participate in interactive features of our service, when you choose to do so; and
- As part of our efforts to keep our site safe and secure;
- For any other purpose that we may notify you of from time to time, providing that we have sought your consent.

Disclosure of Your Information

Talexes will not disclose your personal information to any third party except as follows:

- In order to comply with the law or requests by law enforcement agencies, to enforce our Terms and Conditions or to protect the rights, property or safety of our services, users or others; and
- In the event that all or substantially all of the business or assets of Talexes relating to this service are sold or otherwise assigned to another entity, personally identifiable information may be transferred to such entity.

Talexes may disclose to carefully chosen third parties navigational and transactional information in the form of anonymous, aggregate usage statistics (including "page views" on this website and the products therein) and demographics but only in forms that do not reveal your identity or personal information.

Cross Border Transfers

Talexes may transfer your personal information outside of your country of residence for the following reasons:

- In order to process your transactions. This may occur on servers in countries other than the country where you live. Talexes has servers in Canada. Such processing may include, among other things, the fulfilment of your assessment requests.

By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and all applicable data protection laws.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to us; any transmission is at your own risk. Once we have received your information, we will use all commercially reasonable efforts to prevent unauthorized access to such information.

Cookies

Talexes uses cookies on its websites. Cookies are small text files containing a string of characters that can be placed on your computer or mobile device that uniquely identify your browser or device.

What are cookies used for?

Cookies allow a site or services to know if your computer or device has visited that site or service before. Cookies can then be used to help understand how the site or service is being used, help you navigate between pages efficiently, help remember your preferences, and generally improve your browsing experience. Cookies can also help ensure that what you see online is more relevant to you and your interests.

What types of cookies does Talexes use?

Talexes generally uses three categories of cookies: “Strictly Necessary,” “Performance,” and “Functionality.” You can find out more about each cookie category below.

1. **Strictly Necessary Cookies.** These cookies are essential, as they enable you to move around the Site and use its features, such as accessing logged in or secure areas.
2. **Performance Cookies.** These cookies collect information about how you have used the Site, for example, information related to the unique username you have provided, so that less strain is placed on our backend infrastructure. These cookies may also be used to allow us to know that you have logged in so that we can serve you fresher content than a user who has never logged in. We also use cookies to track aggregate Site usage and experiment with new features and changes on the Site. The information collected is used to improve how the Site works.
3. **Functionality Cookies.** These cookies allow us to remember how you’re logged in, when you logged in or out, the state or history of Site tools you’ve used. These cookies also allow us to tailor the Site to provide enhanced features and content for you and to remember how you’ve customized the Site in other ways. The information these cookies collect may be anonymous, and they are not used to track your browsing activity on other sites or services.

How long will cookies stay on my device?

The length of time a cookie will stay on your computer or mobile device depends on whether it is a “persistent” or “session” cookie. Session cookies will only stay on your device until you stop browsing. Persistent cookies stay on your computer or mobile device until they expire or are deleted.

First and third party cookies

First-party cookies are cookies that belong to Talexes, third-party cookies are cookies that another party places on your device through our Site. Third-party cookies may be placed on your device by someone providing a service for Talexes, for example to help us understand how our site is being used.

How to control and delete cookies
